

**CITY OF JACKSONVILLE BEACH, FLORIDA, EXTENSION NO. 19 OF  
DECLARATION OF A STATE OF EMERGENCY (COVID-19)**

**WHEREAS**, on March 9, 2020, State of Florida Governor Ron DeSantis issued Executive Order No. 20-52 that declared a Public Health Emergency in the State due to the dangers of COVID-19, and that authorized local governments to take any prudent action necessary to ensure the public health, safety, and welfare; Executive Order No. 20-52 has twice been extended, currently through September 5, 2020 (“Governor’s Emergency Declaration”); and

**WHEREAS**, on March 13, 2020, Duval County/City of Jacksonville Mayor, Lenny Curry, issued Emergency Executive Proclamation 2020-001 that declared a state of emergency exists due to COVID-19, in the Consolidated City of Jacksonville, including the City of Jacksonville Beach (“City”); on June 29, 2020, Mayor Curry issued a new Emergency Executive Proclamation 2020-005 (“County’s Proclamation”), in which he again declared a state of emergency continues to exist in the Consolidated City of Jacksonville, including the Beaches communities and the City; and

**WHEREAS**, the Governor’s Emergency Declaration, the County’s Proclamation and many other emergency orders are issued to implement safety measures and mitigation efforts to protect the public health, welfare, and safety; and

**WHEREAS**, on March 13, 2020, the City issued a Declaration of a State of Emergency (“City’s Declaration”) to activate and implement safety and mitigation measures to protect the health, welfare, and safety of City residents, businesses, and staff against COVID-19 risks; and

**WHEREAS**, pursuant to Section 252.38(3)(a)5., Florida Statutes, the limitation for local governments to declare a local emergency is seven (7) days, with 7-day extension increments; and

**WHEREAS**, the COVID-19 public health emergency persists, and local safety measures and mitigation efforts continue to be necessary; therefore the City’s Declaration is extended to continue emergency management plans and to protect the public health, welfare, and safety.

**NOW, THEREFORE**, I, WILLIAM C. LATHAM, MAYOR OF THE CITY OF JACKSONVILLE BEACH, FLORIDA, BY VIRTUE OF THE AUTHORITY VESTED IN ME BY CHAPTER 2, ARTICLE VII, SECTION 2-193 OF THE CITY CODE OF ORDINANCES, ALL APPLICABLE EMERGENCY DECLARATIONS AND PROCLAMATIONS, EXECUTIVE ORDERS, AND FLORIDA LAWS, DO HEREBY DECLARE:

- I. The City’s Declaration initial period was March 13, 2020 through March 19, 2020, and extended in seven (7) day increments from March 20, 2020 through July 23, 2020, inclusive. A state of local emergency continues to exist in the City due to COVID-19. The City’s Declaration is hereby extended for another period of seven (7) days continuously from July 24, 2020 through July 30, 2020 inclusive, to protect the public health, welfare, and safety. The City’s Declaration may be extended, as necessary, in 7-day increments.
