Dear Mayor Hoffman and City Council Members, I'm writing to express my displeasure with the Urban Trail project and specifically the Jacksonville Drive corridor (37th Ave) east of Ponte Vedra Boulevard, and I'm requesting your commitment to revise the current plan for this corridor. My concerns are shared with you, both as a tax paying property owner and a resident citizen of Jacksonville Beach. I, along with a significant number of my neighbors, attended the Jax Beach Urban Trails Community Meeting last night at the Parks & Recreation Community Center. We were aware of the meeting due to door hanger communication document that was placed on our front door more than a week ahead of the session. During the presentation, we were shocked to learn that the Urban Trails Project has been in the works since 2019 with what the CHW, ADG and AYRES consultant said was 'community outreach / input meetings' which of course, none of the interested participants from last night were aware even happened. We were informed that these meetings were communicated on "Facebook", the city of Jax Beach web site and in the Beaches Leader all of which are not on my (or evidently any of my neighbors) radar. When none (or very few) of the impacted property owners have had communication about the 'Community Engagement' meetings, it's abundantly clear that it was ineffective, thus the negative response received last night and the request to change the corridor plan as drafted. For more than 5 years now, since relocating from Ponte Vedra to Jax Beach, we have been asking for a 4 way stop at the intersection of PVB & 37th Ave. for the safety of the citizens that are crossing PVB. We were told by numerous personnel that PV Blvd. is a STATE ROAD and was not under the control of the city of Jacksonville Beach, and that for consideration there was a requirement for five traffic incidents in a 12-month period had to occur. While I believe that it would be a great improvement to the community to provide a crosswalk and a four-way stop at that intersection, we do not believe that the urban trail should be the mode of continuance of that route. There is a perfectly acceptable sidewalk that allows pedestrians to traverse from A1A east across PVB and we believe it would be a gross waste of taxpayer dollars to 'retrofit' that area with the urban trail plan as proposed. Additionally, we would strongly suggest the continuation of the sidewalk eastward from PV Blvd. all the way to the Beach entrance. Our belief is that the sidewalk should be on the Southern side of 37th Ave to minimally impact the "front facing" residences on 37th, including but not limited to the two homes occupied by residents with special needs. We believe that this would be more consistent with the ambiance of a beach residential neighborhood vs. the currently proposed urban trail design, particularly given that the current proposed plan has TYPE B: Protected Path as what is presently being considered which includes BOTH a sidewalk and multi-use trail, which is not practical in this area.

- If this goes through, we will sue! A 4 way stop is fine at PV BLVD & 37th Ave and necessary, but the rest will disturb How many council members will be affected? We don't need more people up & down our street. If you put it on an already crowded street trying to retrofit some thing that should have been done 50 years ago. WE ARE THE COMMUNITY AND DON'T WANT THE PAVED TRAIL
- 100% opposed to the corridor plan east of Ponte Vedra Blvd on 37th Ave S. There is no point in paving the 200 yards on the N side of 37th. Expense & no real gain. Change the 37th corridor plan. We are strongly opposed to the "urban trails" coming thru 37th Ave S. Our intersection is extraordinarily dangerous and poses a severe ADA violations. The corridor between PV Blvd and 37th Ave South does not need the Urban Trail due to low pedestrian activity and a low flow vehicle activity. This is unnecessary use of trail dollars to fix a problem that isn't there. This area isn't area that needs improvemet. Implimentation of said plans cause a health risk for our street. We have 3 handicapped residents on this street. They will be in contact with ADA attornies if needed. Our neighbor is severely disabled. The trail will impair him from access to his disability van. It sits in front of our neighbors home for a minimum of 10 minutes. The trail will be a violation of his ADA rights. *A written response to our concerns is not only appreciated but necessary for legal purposes.

Residence address 139 37th Ave S. I purchased the lot in December 2019. We were not informed of the trail plan that could impact the area in front of our home. My wife and I searched for our retirement home and would not have purchased this property if we had known. Since we have lived here, over 2 1/2 years, we have not observed signifigant non-residential vehicle traffic on our street. Pedestrians, runners, cyclists and cars all share the road well. The issue is the lack of a marked crosswalk and stop sign on PV Blvd. The trail east of PV Blvd is totally unnecessary, and any funds allocated for that area can be re-allocated. I disagree with the assertation that the proposed trail on 37th ave S will not adversely affect property values. I respectully as the City Council to alter the plan for the trails in the Jax Drive corridor and stop the trail immediately after crossing PV Blvd. My youngest son has disabilities, and the proposed trail path will adversely impact his ability to ride his bicycle due to a decreased distance to start.
